

## Transparency declaration by 3D NV: Threshold crossed

**Kortrijk, Belgium, 9 March 2022, 18.00 hrs** – 3D NV, Gent - Belgium, has notified Barco (Euronext: BAR; Reuters: BARbt.BR; Bloomberg: BAR BB) it has crossed the statutory threshold of 5%, holding 4,638,166 shares i.e. 5.03% of Barco's shares and voting rights as of 7 March 2022.
