Since the start of the share buy-back program on 19<sup>th</sup> December 2023, Barco NV has bought back 2,000,000 shares for a total amount of 32,611,232 euros. This corresponds to 100% of the program completed.

After aforementioned transactions the total number of own shares amounts to 4,335,943 shares on the date of 23rd February 2024.
